B. Presentation

Mr. Brian Williams, Assistant Superintendent, presented a school district update which he listed many positive things happening in the district. He started by reviewing test scores from the Ohio Department of Education. The district ranked 75th out of 607 school districts in Ohio on the performance index and 25th out of 598 school districts in gifted. The district recently held a wellness fair which included 30 vendors and hundreds of participants. The technology department has done a great job servicing the 3500 personal devices and all of the other technology needs of the district. The Akron Beacon Journal once again named Copley-Fairlawn City School District as the best public school district in the five county area. The district participates in the 4 Cities district compact which offers over 20 technical programs. The newest additions are the pharmacy tech and animal tech both housed at Copley High School. The Kiwanis recently held a fund raiser and they were able to raise over \$22,000 to help families in need during the holidays. The high school key club was able to raise \$600 to assist with families in need. The high school marching band achieved a "1- Superior" rating at the state competition. The high school cyber patriot team is ranked 1st in the state in security breach category. 2 high school students are national merit finalists. In athletics, Wally Senk, girls' soccer coach was selected as coach of the year in the area. Dave Antal, boys' soccer coach, achieved 200 wins for his coaching career. The girls' volleyball team was district runner-up which is the highest achievement for that team. The cross country team had one boy qualify for the state meet. There is a new scoreboard installed in the auditorium thanks to donations which paid about 40% of the overall cost. A new program at the middle school where 7th and 8th grade students mentor 5th and 6th grade students has been going really well and may expand to the high school. The middle school PTA was able to raise \$11,000 during their fundraiser. At the primary buildings there are many after school activities and clubs that students have been participating in. In conclusion, Mr. Williams stated that there are so many positive things happening within the school district and he only mentioned a short list.
