# E. New Business

#### 1. COVID Update

Mr. Poe, Superintendent, reported that 4 staff and 4 students have tested positive in the past 2 weeks. The school district has purchased HEPA 13 air purifiers/filters and they have been installed in each classroom and office. The filters are medical-grade air filters capable of removing a minimum of 99.95% particles including those that cause the coronavirus.

## 2. Vaccination - Thank You

President Coon on behalf of the Board of Education, thanked the administrators, custodians, and all other staff that worked on organizing the vaccination days. He noted 420 vaccines were distributed each day and it went very well.

#### 3. Winter Athletics

President Coon congratulated the winter sports teams for a successful season. 5 wrestlers made it to the Ohio High School Athletic Association (OHSAA) state meet and 2 of them are state champions, 2 placed 5<sup>th</sup> and 1 placed 6th; 1 swimmer made it to the state meet and finished in 5<sup>th</sup> place; 1 gymnast placed 9<sup>th</sup> at the state meet; and the boys' and girls' basketball teams both won tournament games.
